



IMPORTANT INFORMATION ABOUT PROPOSED INCREASES IN ELECTRIC RATES

On May 8, 2007, SCE filed its 2008 Cost of Capital Application with the California Public Utilities Commission ("CPUC"). The CPUC designated the application as A.07-05-003. It requests an increase in SCE's revenue requirement of \$16.902 million, or 0.15 percent.

This application is necessary to establish SCE's authorized cost of capital for 2008. The authorized cost of capital determines how much money SCE is allowed in rates as a return on its invested capital. In this proceeding, the Commission will determine the reasonable costs of long-term debt, preferred stock, and common stock that are part of the authorized cost of capital. The authorized cost of capital adopted in this application will be applied to the rate base authorized by SCE's post test year ratemaking mechanism established in D.06-05-016. SCE currently estimates that the resulting annual revenue requirement increase for SCE's 2008 cost of capital will be approximately \$16.902 million.

SCE is requesting a return on common equity of 11.8% and a return on rate base of 8.87%. SCE's requested cost of capital will fairly compensate those who invest in SCE, and permit SCE to attract capital to meet its obligations to serve its customers safely and efficiently. It will also allow SCE to mitigate financial effects in 2008 resulting from purchased power contracts.

The following table shows an estimate of proposed revenues and rate changes by customer group. The percentage increase in total revenue is less than one percent. Any revenue change resulting from this application will be consolidated with revenue changes from other SCE applications.

On an illustrative basis, if total rates were to change as requested, an average residential electric customer using 700 kilowatt-hours per month in the summer would see an increase of \$0.16 per month, from \$97.00 to \$97.16.

THE CPUC WELCOMES YOUR PARTICIPATION AND COMMENTS

The CPUC will issue its decision after evidentiary hearings on SCE's request. At the hearings, SCE representatives, interested parties, and the CPUC's Division of Ratepayer Advocates ("DRA") will present testimony. The DRA staff of engineers, accountants, economists, attorneys and other professionals independently evaluate utility rate increase proposals and present their analyses and recommendations to the CPUC at evidentiary hearings.
