**Important Notice
Southern California Edison's
2012 Home Energy Efficiency Rebate Program
Variable-Speed Pool Pump Installation Incentive!**

Southern California Edison ("SCE") is offering a \$100 incentive to pool pump retailers/contractors for each qualifying residential variable-speed pool pump purchased and installed at an SCE customer residence during 2012. This incentive is for you, the retailer/contractor, and is in addition to the \$200 incentive an SCE residential customer may be eligible to receive.

In addition to your incentive, your customer may be eligible for a \$200 incentive for qualifying equipment purchased between January 1, 2012 and December 31, 2012. Funding is limited and this program may be terminated without prior notice by SCE upon depletion of funds.

In order to be eligible for this incentive you must meet the following requirements, provided however, that SCE reserves the right to modify these requirements at anytime:

- 1) Be the SCE customer's source for the purchase and installation of a qualifying variable-speed pool pump on or after the effective date of your signed Participation Agreement (attached). The SCE customer is required to submit your invoice with his or her Customer Rebate Application. Please note, that **the SCE customer MUST submit the applicable Customer Rebate Application for a qualifying variable-speed pool pump in order to initiate your eligibility for this \$100 incentive.**
- 2) You must sign the attached Participation Agreement and mail it back to:

SCE will provide you with a confirmation receipt of your signed agreement via email, at which time you will be considered a valid participant of this incentive offer. Only those installations that take place on or after the date SCE provides you in its confirmation letter are eligible.

3) When the SCE customer submits his/her Customer Rebate Application with your invoice, the SCE rebate processing center will match the invoice with the Customer Rebate Application and your signed Participation Agreement. If all required documents are found to be satisfactory, in SCE's sole opinion, SCE will mail you a check for the \$100.00 incentive for each application that is verified according to the above process. Please note that due to customer confidentiality, SCE will not provide you with the name of any customer who submits their rebate. It will be your sole responsibility to verify with your customer that they have submitted their Customer Rebate Application accompanied by your invoice.

This program is funded by California utility ratepayers and administered by SCE under the auspices of the California Public Utilities Commission.

I understand and agree to the following terms and conditions of this incentive:

1) This incentive is for a limited time only, from the date provided to me in the confirmation email I will receive from SCE. I understand that qualifying purchases must be made between January 1, 2012 and December 31, 2012 and installed at an SCE residential service address by December 31, 2012. I further understand that my customer must submit the Customer Rebate Application to SCE, with my invoice attached, postmarked no later than February 28, 2013 for qualification of both my incentive and customer's incentive. Incomplete applications will not be accepted.

2) I understand that the retailer or contractor incentive will be paid on a first-come, first-served basis while funding lasts to the participant whose name appears on both the invoice attached to the qualifying Customer Rebate Applications received by SCE according to the terms and conditions of that application AND on this executed Participation Agreement, according to the terms and conditions of this Agreement.

3) This Agreement must be signed and returned to:

4) I will only receive payment of the \$100 incentive for those qualifying Customer Rebate Applications that have attached an invoice with the Company name referenced above or otherwise indicates to SCE's sole satisfaction that I am the installer of the qualifying product. If I own or operate a chain of stores, I will submit a list of all such stores by name and address with this executed agreement.

5) I hereby verify and shall ensure that the variable-speed pool pumps that I install will be set to operate for the SCE customer as intended at its variable speeds as appropriate and I agree to inform Customer of the energy-savings benefits of setting the timer to operate during "off peak hours" (i.e., other than between Noon and 5 PM).

6) I will encourage the customer to submit the appropriate Customer Rebate Application and make every effort to have it postmarked within 30 days of installation.

7) I understand that Customer's Rebate Application (with invoice) must be postmarked by February 28, 2013 for both retailer/contractor and customer incentive eligibility. I further understand that this offer remains subject to available funding and that this program may be modified or terminated by SCE without prior notice.

8) This incentive for participating retailers and contractors is in addition to the SCE customer's rebate. Only one incentive for participating retailers/contractors and for the SCE customer is paid for each qualifying installation. Only one such pool pump rebate is allowed per residence.
