SUBJECT: Southern California Edison Company's 2006-08 Energy
Efficiency Compliance Filing

In compliance with Decision (D.) 05-09-043, Southern California Edison Company (SCE) hereby submits for filing its 2006-08 Energy Efficiency Program Plans. These final program plans, along with all necessary supporting documentation, are attached hereto.

PURPOSE

The purpose of this advice letter is to comply with the California Public Utilities Commission's (Commission) directive to submit SCE's final 2006-08 energy efficiency program plans in accordance with D.05-09-043.

BACKGROUND

In D.05-09-043, the Commission adopted SCE's 2006-08 energy efficiency program plans, effective January 1, 2006, on an interim basis, until the Commission approves SCE's final program plans which are to be submitted through a compliance filing and after SCE completes its competitive program bid solicitation process. SCE has successfully completed its program solicitation and has developed its final 2006-08 energy efficiency program plans. This advice letter serves as SCE's compliance filing required by D.05-09-043.

The final program plans attached hereto comport with all applicable Commission directives regarding this 2006-2008 energy efficiency compliance filing. The filing includes the information requested in D.05-09-043, including all details of the bid process, the scenario analyses performed around SCE's cost-effectiveness calculations, and an updated bill impact calculation.

No cost information is required for this advice filing.

This advice filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other schedule or rule.

EFFECTIVE DATE

This advice filing will become effective on the 30th calendar day after the date filed, which is February 5, 2006.
